Location: The property is located on the south side of U.S. Highway 12 (i.e. 11160 U.S. Highway 12, Naches, WA), is approximately 0.7 miles west of South Naches Road, and is approximately 0.4 miles west of the city of Naches, Washington.

Zoning: Light Industrial (i.e. M-1)

Proposal: The applicant is proposing to establish a woodworking facility in the Light Industrial zoning district. The facility contains 26 buildings that amount to 111, 214 square feet. Six buildings, amounting to 6,350 square feet, are not in use or empty. The application is being reviewed under the Type 1 Process and SEPA Review.

This proposal is subject to environmental review. The Planning Division is lead agency for this proposal. Yakima County expects to issue a **DNS** for this proposal. The proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared. After all comments have been received and considered, a final threshold determination will be made without an additional comment period. **Any person may provide written comments on issues related to the proposal. All written comments received by 4:00 p.m., September 11, 2017 will be considered prior to making the final decision.** Mail your comments on this project to Yakima County Planning Division, 128 N. 2nd St., 4th Floor Courthouse, Yakima, WA 98901. Be sure to reference the above case number in your correspondence. Notice of the final decision will be sent to those who comment or may be obtained upon request. The final decision will contain specific appeal information and may be appealed within 14 days of the date of issuance.
