## DESCRIPTION OF PROPOSAL

Applicant: Bill Hordan on behalf of Bron Yr Aur Investment Corp.

**Location:** 12160 US Highway 12. Located on the southwest side of US Highway 12, approximately 0.75 miles northwest of the intersection of US Highway 12 and West Naches Road, approximately 1.25 miles northwest of the City of Naches, WA.

**Proposal:** The applicant has proposed to construct a new 1,600 square foot craft distillery to an existing microbrewery. A 60 square foot tasting room will be located within the distillery. Two employees are proposed with 39 gravel parking spaces. The hours of operation will be Wednesday & Thursday 4pm-8pm, Friday & Saturday 12pm-9pm, and Sunday 12pm-8pm. During the summer months they will also be open Monday 4pm-8pm. The parcel is accessed via US Highway 12.
