DESCRIPTION OF PROPOSAL

Applicant: Nimo Construction, LLC on behalf of Elias & Maria Torres

Location: 421 Puterbaugh Road. The subject parcel is located on the east side of Puterbaugh Road, approximately 500 feet south of the intersection of Forsel Road and Puterbaugh Road, and abutting the western border of Grandview, WA city limits.

Tax Parcel No.: 230922-22402

Proposal: The proposal will establish a child day care center inside of an existing single-family residence. The day care center will have approximately 12 children and there is a proposed outdoor play area west of the single-family residence. The day care will operate Monday through Friday from the hours of 7am to 4pm. Two employees will operate the day care center. The existing well on the property and existing septic system will be utilized. Access is via a private-shared driveway from Puterbaugh Road.

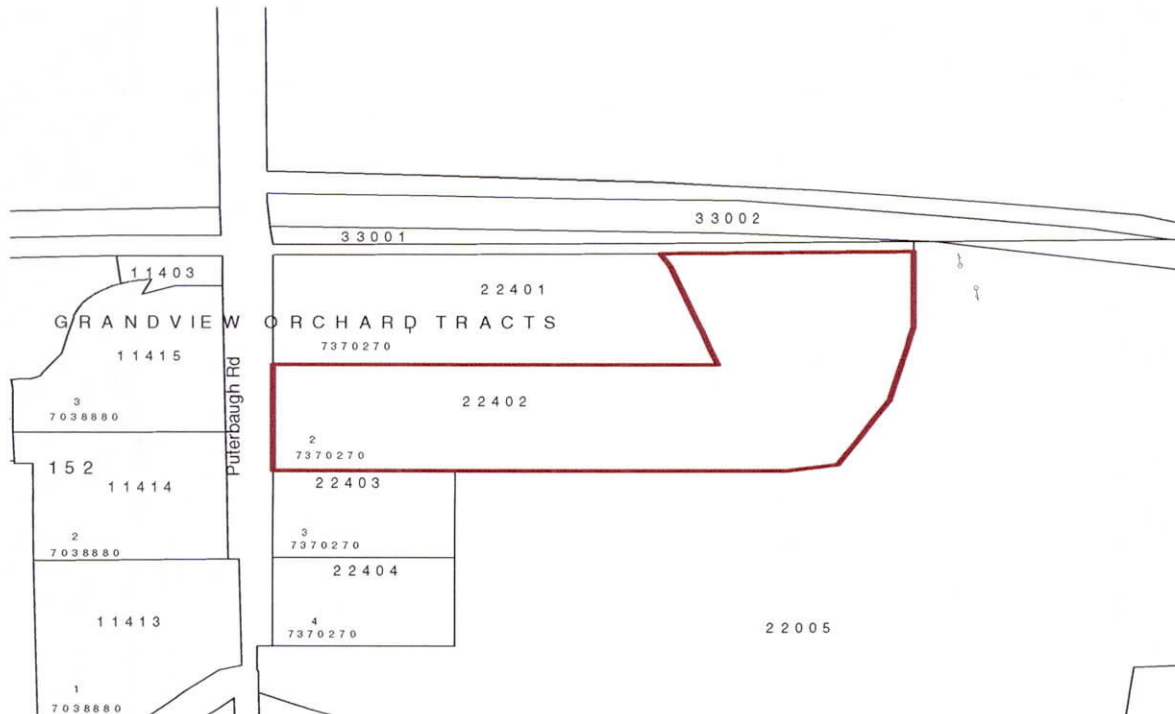
