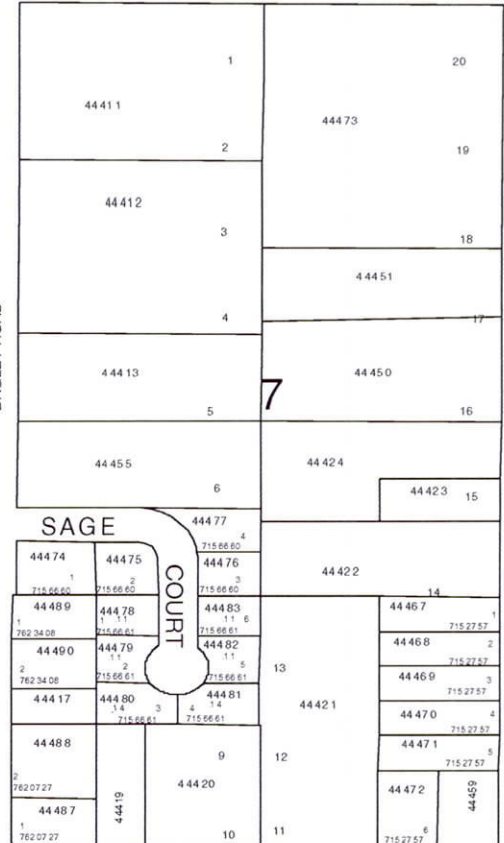
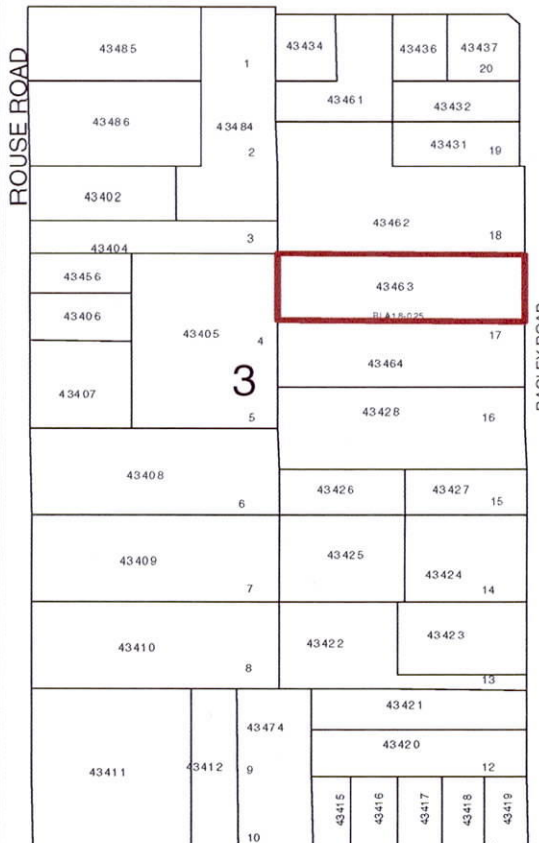
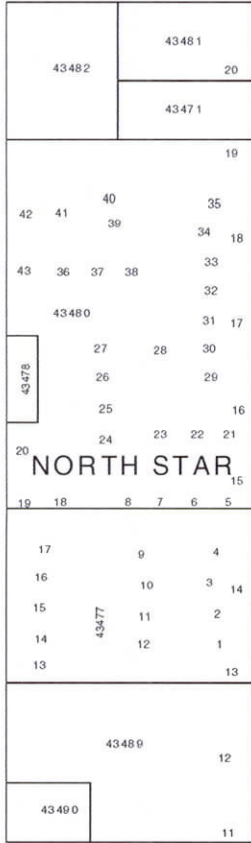
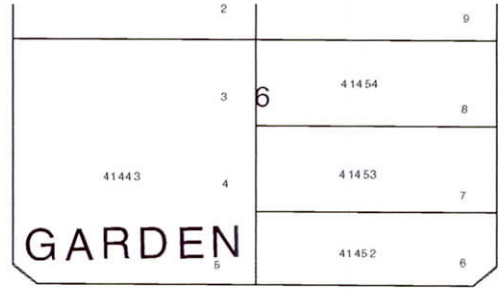
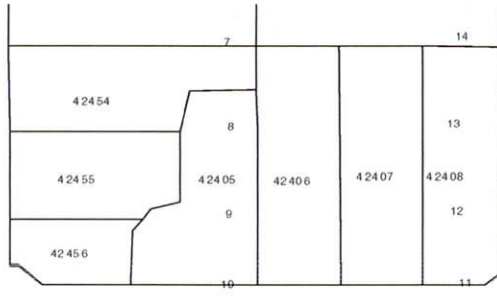
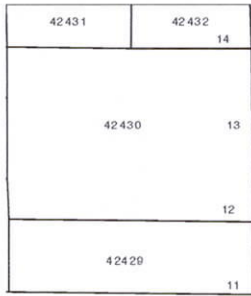
COMMENT AND APPEAL INFORMATION
