Location: 351 Glade Road. The subject parcel is located on the east side of Glade Road, about 900 feet south of the intersection of Glade Road and Maple Street, approximately 900 feet south of the City of Mabton, WA.

Proposal: The proposal is for a Type 1 Agriculturally Related Industry with a SEPA environmental review for an existing hop facility. The project involves removing a 6,500 sf hop picker building and a 2,600 sf bale building and adding an 11,340 sf kiln building and an 18,000 sf bale building. Future projects will involve adding a 15,000 sf storage building and an 18,000 gallon LPG tank.

This proposal is subject to environmental review. The Planning Division is lead agency for this proposal. Yakima County expects to issue a DNS for this proposal. The optional process authorized by WAC 197-11-355 is being used. This may be your only opportunity to comment on the environmental impacts of the proposal. The proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared. After all comments have been received and considered, a final threshold determination will be made without an additional comment period. **Any person may provide written comments on issues related to the proposal. All written comments must be received by 4:00 p.m., December 26, 2017.** To be considered prior to making the final decision, all submitted comments must identify the name and physical or post office address of the sender. **Mail your comments on this project to Yakima County Planning Division, 128 N. 2nd St., 4th Floor Courthouse, Yakima, WA 98901. Be sure to reference the above case number in your correspondence.** Notice of the final decision will be sent to those who comment or may be obtained upon request. The final decision will contain specific appeal information and may be appealed within 14 days of the date of issuance.
