## **DESCRIPTION OF PROPOSAL**

On January 31, 2018, the Yakima County Public Services Department received an application for the 2018 Biennial Comprehensive Plan Map Amendment from Hordan Planning Services to amend the Yakima County Comprehensive Plan – **Horizon 2040** Future Land Use Map. The applicant proposes the Mineral Resource Overlay designation on 186 acres of an approximate 610-acre parcel while retaining the underlying current Remote/Extremely Limited Development Potential (R/ELDP) zone and Remote/Extremely Limited Development Potential (R/ELDP) land use designation.

Location: The subject property is located north of Highway 410, approximately two miles west of Highway 410 and Highway 12 intersection, and approximately six miles west of the town of Naches. The subject property is identified as Assessor's Parcel 161527-11001.

## **ENVIRONMENTAL REVIEW**

This proposal is subject to environmental review. The Yakima County Planning Division is lead agency for this proposal under the State Environmental Policy Act (SEPA). The environmental checklist and other information on file with the Planning Division are available to the public as described below. Comments on the proposal will be used to prepare a preliminary environmental threshold determination, which will then be issued for additional comments.

All written comments received by 4:00 p.m., April 27, 2018 will be considered prior to making the preliminary environmental threshold determination. above file number in your correspondence. To be considered prior to making the final decision, all submitted comments must identify the name and physical or post office address of the sender. Copies of the final threshold determination will be sent to those who comment or may be obtained upon request. There will be no administrative appeal of the final threshold determination. (WAC 197-11-680). The threshold determination decision is associated with a comprehensive plan amendment which is a legislative action, and is not subject to the permit processing requirements specified in Y.C.C 16B.02.090. 
