DESCRIPTION OF PROPOSAL

Justin Wamsley has submitted a grading permit application and Washington State Environmental Policy Act (SEPA) Environmental Checklist within the Agricultural Zoning District (AG). Mr. Wamsley has graded approximately 1500 cubic yards to facilitate a building site for a future private garage/shop.

Location: 481 South Wenas Road. The proposal is located on the north side of South Wenas Road; approximately ½ mile north of Hexon Road; 3 miles north of the City of Selah. (Parcel No. 181414-11400)

ENVIRONMENTAL REVIEW

This proposal is subject to environmental review. The Yakima County Planning Division is lead agency for this proposal under the State Environmental Policy Act (SEPA). The environmental checklist and other information on file with the Planning Division are available to the public upon request. Yakima County expects to issue a DNS for this proposal. The optional process authorized by WAC 197-11-355 is being used. This may be the only opportunity to comment on the environmental impacts of the proposal. The proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared. After all comments have been received and considered, a final threshold determination will be made without an additional comment period.

COMMENT AND APPEAL INFORMATION

Your views on the proposal are welcome, and any person may provide written comments on issues related to the proposal. **All written comments received by 4:00 p.m., April 11, 2018 will be considered prior to making the final decision.**

Mail your comments on this project to Yakima County Planning Division, 128 N. 2nd St., 4th Floor Courthouse, Yakima, WA 98901. Be sure to reference the above file number in your correspondence.

Copies of the final decision will be sent to those who comment or may be obtained upon request. The final threshold determination can be appealed to the Hearings Examiner within 14 days of the date of issuance, as allowed under the Yakima County Code.

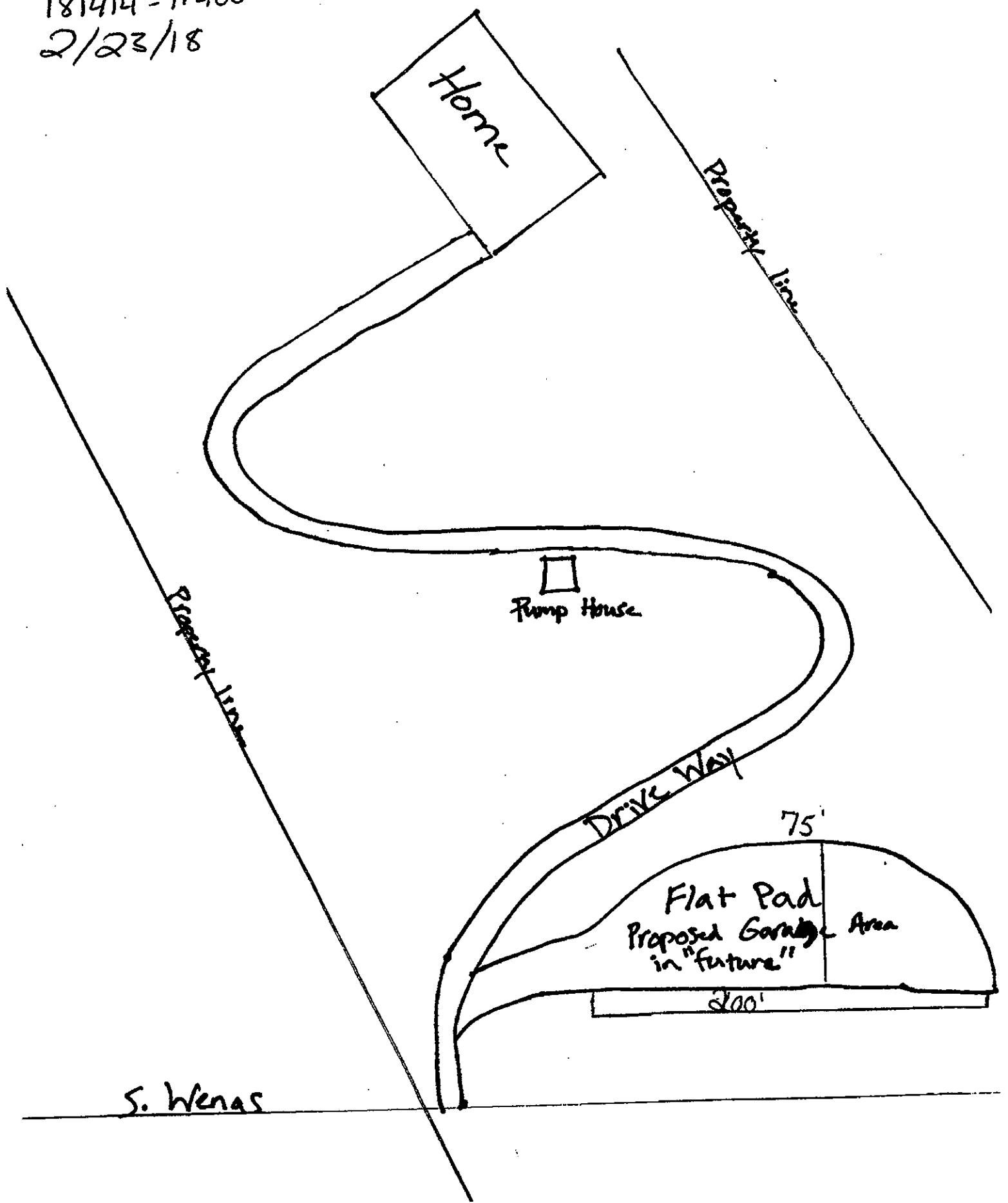


