Proposal: The applicant is proposing to subdivide a 3.01 acre parcel into a 2 acre parcel and a 1.01 acre parcel. The 1 acre parcel will be vacant and is proposed to be served by an individual well and individual septic system. Access to the subject parcel is via Hawkins Road.

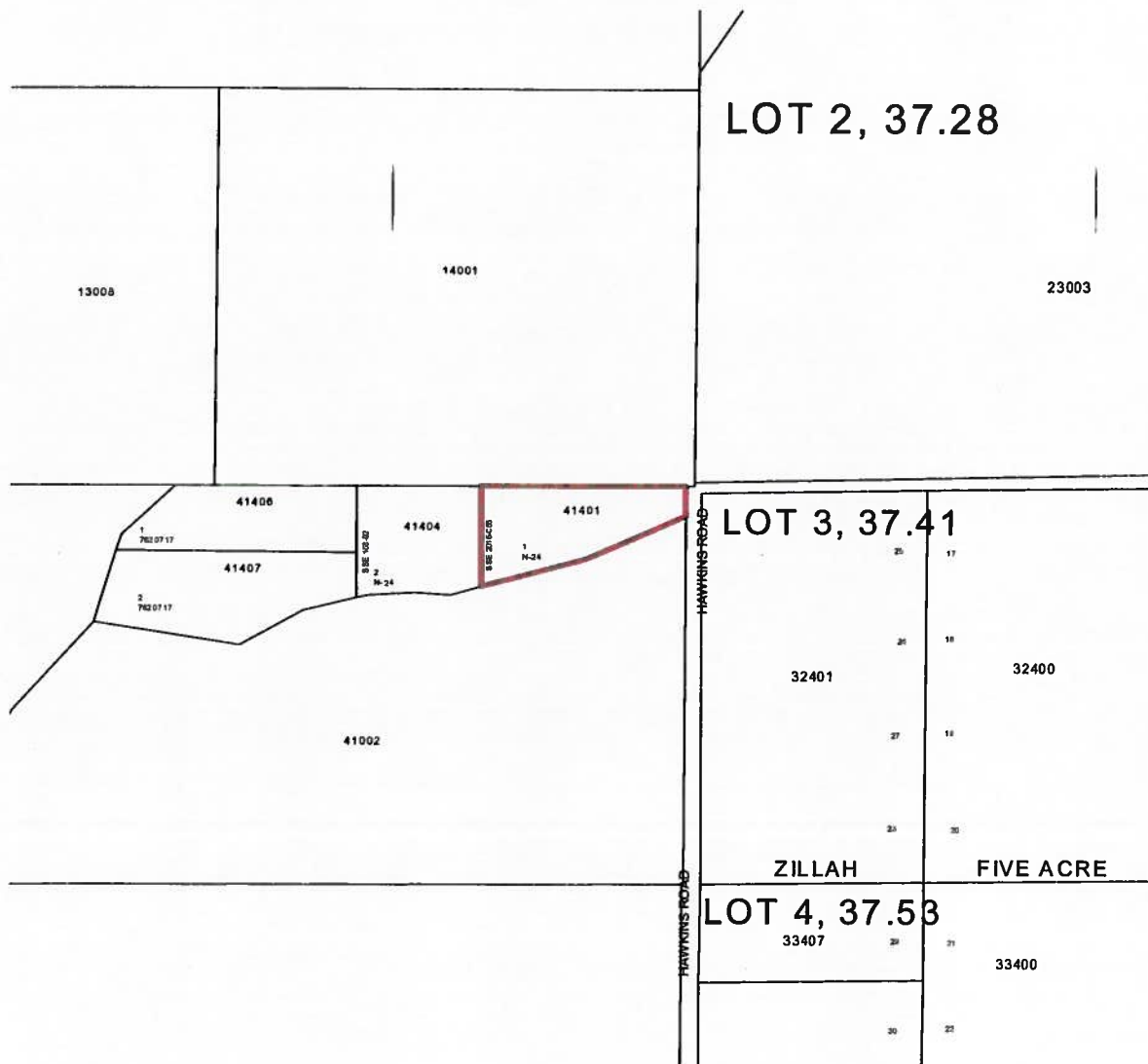
COMMENT AND APPEAL INFORMATION
