Mr. Wilton:

The Yakima Health District has reviewed the above referenced application regarding water systems that may be associated with this project according to the requirements in YCC 19.25.040. A site visit was not done as a part of this review. Our findings are presented below:

Group A Water Systems

We checked our files and the Washington State Department of Health community water system database (SENTRY). We did not find any existing Group A water systems within 200 feet of this development.

Group B Water Systems

We checked our files and the Washington State Department of Health community water system database (SENTRY). We did not find any existing Group B water systems within 200 feet of this development.

2-Party Shared Wells

We have reviewed the supplied information and information in our files regarding the existing well serving the existing residence in this project. This review showed encroachments in the 100-foot sanitary control area for this well (the house/garage in this case). However, if a well log for this well is located and that well log shows protections such as the well being drilled through and sealed into impermeable layers, it may be approvable as a shared well. For this determination to be made, this well will need to go through the shared well (2-party) approval process with the Yakima Health District, including application and fee payment. If no shared well review is done, then this well is

not acceptable as a shared well. This determination is not an approval of this well as a shared well.

Individual Well(s)

The existing well at this site does meet the criteria for an individual well serving one single family residence.

No review of water quantity or availability was done by the Yakima Health District. Our review of your water system does not confer or guarantee any right for you to withdraw or divert groundwater. Contact your local planning department, the Washington State Department of Ecology, or the Yakama Nation for more information about your legal rights to use groundwater.
