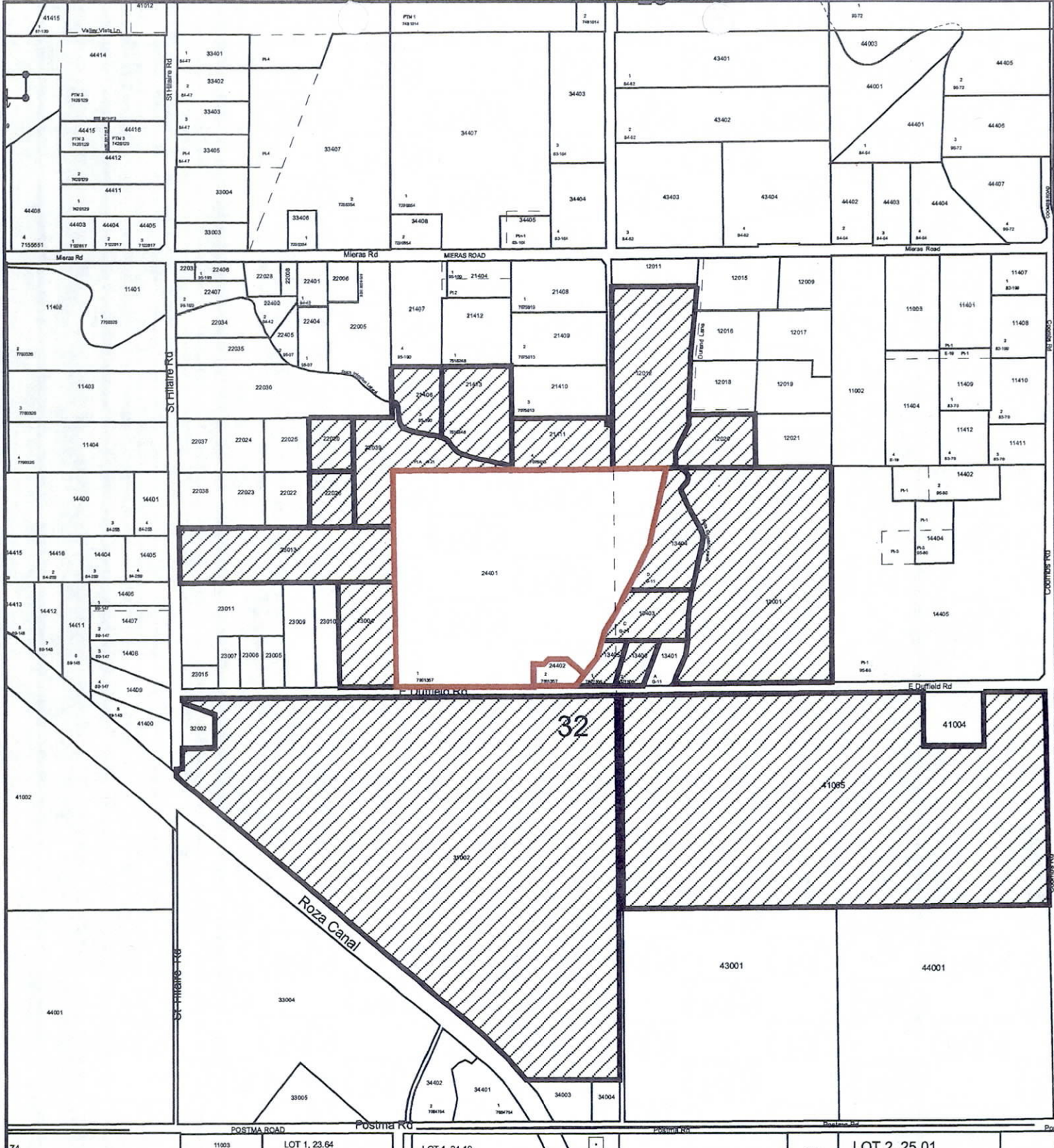
## COMMENT AND APPEAL INFORMATION
