DESCRIPTION OF PROPOSAL

Applicant: Bill Hordan, with Hordan Planning Services, on behalf of Gary Trepanier

Location: 9035 Naches Heights Road. The subject parcel is located on the northeast side of Naches Heights Road, about 960 feet east of the intersection of Naches Heights Road and Whitten Road, approximately 3 miles east of Tieton, WA.

Tax Parcel No.: 171422-21406

Application Submittal Date: June 28, 2018 **Completeness Date:** September 4, 2018

Proposal: The subject parcel is within the Agriculture (AG) zoning district. The applicants are proposing to divide the approximately 29.34 acre parcel into two lots using the Small Lot Provision. Lot 1 is to be about 27 acres in size and is currently vacant. Lot 2 is to be 2.5 acres in size and contain the existing residence. Lot 1 will access onto Rudd Road via an existing road approach. Lot 2 will access onto Naches Heights Road via a private road. Domestic water for the existing residence on Lot 2 will continue to be from a community well on parcel 171422-13406. Lot 1 will be served domestic water from a proposed 2-party shared well located on parcel 171422-24412.

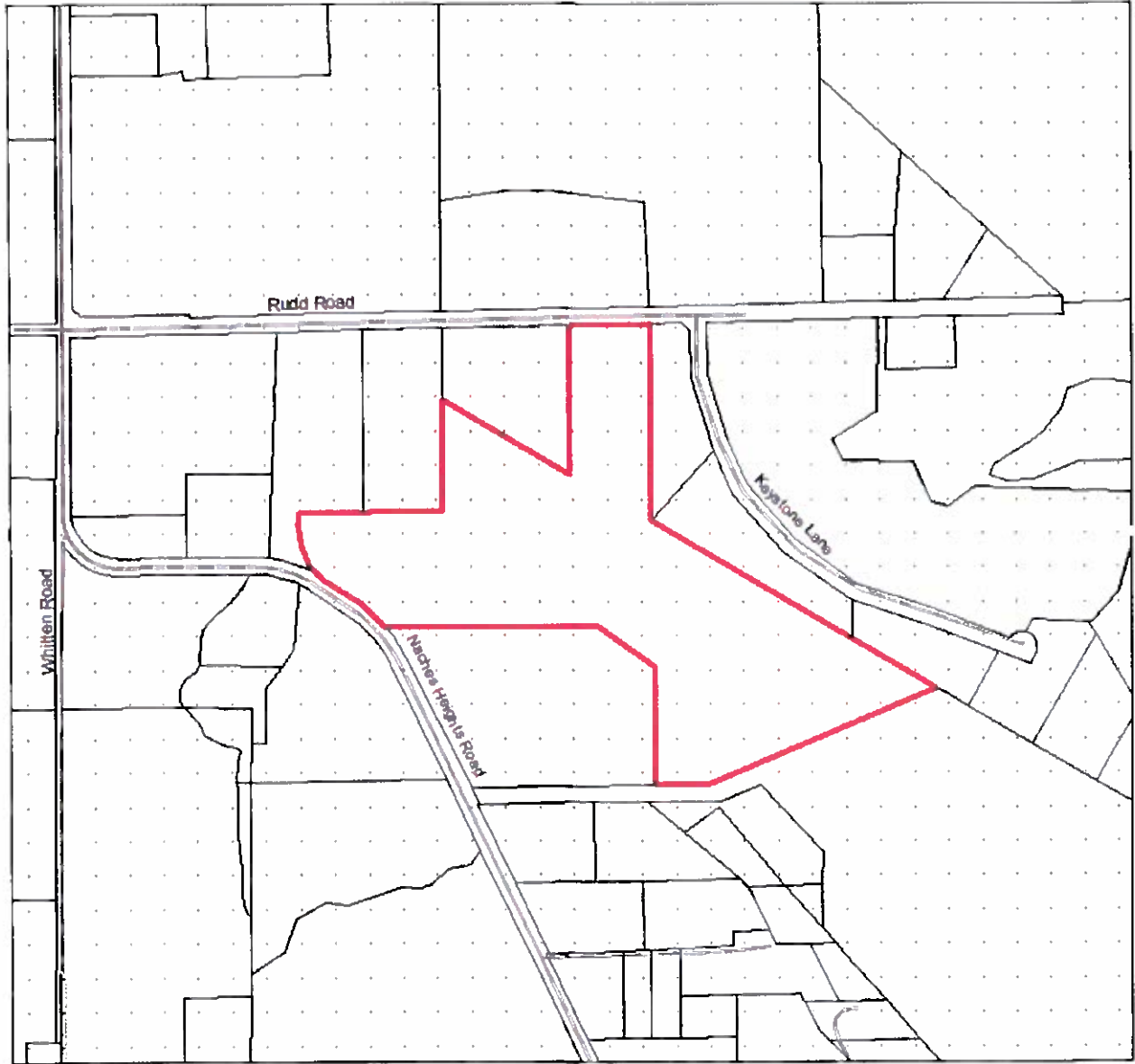
COMMENT AND APPEAL INFORMATION

The final decision will contain specific appeal information and may be appealed within 14 days of the date of issuance.
