DETERMINATION OF NON-SIGNIFICANCE
(Notice of Action)

1. **Description of Proposal:** Shayne and Lesley Downing submitted a Type 4 Application for a Minor Rezone to rezone a 2.50 acre parcel from Rural 10/5 (R-10/5) to Remote/Extremely Limited Development Potential (R/ELDP) along with an Environmental Checklist (SEPA). The rezone will allow a future Boundary Line Adjustment with the adjacent parcel (161536-11407), to put the existing residence, shop, and barn on one parcel creating a 7.09 acre parcel. The remaining land to the north is adjacent to land owned by the Washington Department of Fish and Wildlife established as the Oak Creek Wildlife Area.


4. **Location of Proposal:** The subject parcel is adjacent to 13733 Old Naches Highway, located north of Old Naches Highway, approximately one (1) mile northeast of the intersection of Old Naches Highway and SR 410, and approximately 2.5 miles northwest of the City of Naches. Parcel no. 161536-11405

5. **Lead Agency:** Yakima County Planning Division

6. **Determination:** The lead agency for this proposal has determined that it will not have a probable significant adverse impact on the environment and an Environmental Impact Statement (EIS) is not required under RCW 43.21C.030(2)(c). This decision was made after a careful review of the completed environmental checklist, and other information on file with the lead agency.
